- All applicants must reside within the Washington DC Metropolitan area and show proof of residence.
- The actual wedding will take place in the Washington DC Metropolitan Area.
- All applicants must be active participants or employees of a non-profit community outreach organization within the Washington DC Metro Area.
- Applicants must not be able to afford a wedding on their own accord. The wedding has an estimated value of \$30,000. Proof of salaries may be asked upon request by the director of the Washington DC Couture Wedding Consortium.
- All vendors are chosen by the Washington DC Couture Wedding Consortium and limitations to the services depend on the sole discretion of each vendor donating their particular product or service. If for any reason the couple that is chosen for the 2nd Annual Charity Wedding would like to enhance the donated products or services provided by the vendors, the difference in cost will be the sole responsibility of the couple chosen.
